


# Donor Advised Fund

### CREATE A NAMED FUND AND LEAVE A LEGACY

If you have an idea for making a local difference, launching a fund through the WCF lets you operate like a nonprofit while the foundation handles accounting, legal, and fundraising tasks. One option is a Donor Advised Fund (DAF), which allows donors to create a philanthropic fund and recommend distributions for charitable purposes. Establishing a DAF is straightforward, requiring only an initial contribution and Fund Agreement between the foundation and the donor. These funds can be named and are endowed or non-endowed.



#### **HOW ARE FUNDS INVESTED?**

When creating the Fund Agreement, donors select an investment portfolio type (conservative, balanced, growth, or aggressive growth) based on their risk tolerance. Their assets are pooled with those of other donors with similar profiles.



## **HOW DO I ESTABLISH AND CONTRIBUTE TO A FUND?**

- **Initial Contribution and Fund Agreement**
- Initial and subsequent contributions to a DAF may be made by check, credit card, appreciated stock or publicly traded securities as well as other forms of real property, subject to the Foundation's Gift Acceptance Policy.
- Contributions are generally tax-deductible, though it's advised to consult with a professional advisor.

#### CAN I MAKE A DISTRIBUTION, GRANT, OR DONATION FROM THE FUND AT ANY TIME?

Distributions from DAF funds follow an agreed schedule and require a minimum plus the grant amount. While requests can be made anytime, donors are encouraged to choose annual distributions for better planning by charitable organizations. The Foundation will consider recommendations promptly, with distributions sent within 15 business days.

#### **HOW CAN I PLAN FOR THE CONTINUED USE OF PROCEEDS** FROM MY FUND?

Donors can designate successor advisors to make fund recommendations if they are not able to continue. Without a succession plan in the Fund Agreement, the fund may become subject to the variance power authority of the Board of Directors.

### I OPENED MY **FUND, CAN I** MAKE A DISTRIBUTION **IMMEDIATELY?**

Funds may make distributions immediately upon inception assuming that the distribution is being made to a qualified public charity or government unit and does not exceed the minimum balance of the Fund at the time of the distribution.

#### HOW DO I **RECOMMEND A DONATION?**

In the Fund Agreement with WCF, donors can designate representatives, like family members, to recommend distributions to tax-exempt charities. The Foundation verifies grants, but final decisions rest with it. Recommendations are submitted via a form on the Donor Portal and can continue as long as the fund requirements.
