



VOLUNTEERS WORKING TOGETHER ON CHARITABLE INITIATIVES

Fiscal Sponsorship Funds (FSF) assist local volunteer groups in raising funds to achieve their community goals.

The WCF can extend its tax-exempt status to align with specific volunteer missions, allowing them to collaborate on charitable projects.

In this arrangement, the WCF acts as the sponsor, accepting tax-deductible donations and managing grants or payments for the project while ensuring funds are used appropriately for charitable purposes. The IRS mandates that the sponsor retains "complete discretion and control" over the funds to prevent misuse.

Recently, two Woodbury community residents faced the tragic loss of their children and, in their memory and honor, have established a lasting memorial.

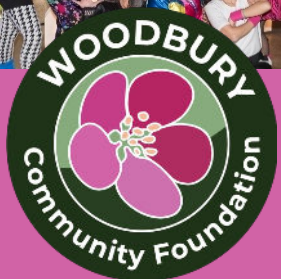

HOW CAN CONTRIBUTIONS BE MADE TO A FISCAL SPONSORSHIP?

Contributions to the Sponsorship Fund can be made in any amount, adhering to the Foundation's Gift Acceptance Policy. A fund can be started with any initial contribution but will be restricted until the minimum spendable balance is exceeded through donations. Distributions will be governed by the terms of the fund's Investment Fund Agreement.

HOW ARE FUNDS INVESTED?

Sponsorship donations for short-term projects are deposited in a checking or savings account, often pooled with other funds managed by the WCF. If a project requires future maintenance or on-going operating expenses, a new Fund Agreement with the WCF may be needed for future funding.

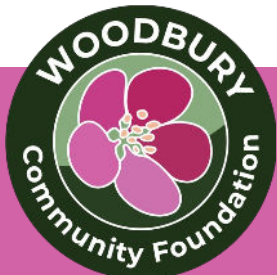
HOW MUCH WILL IT COST MY PROGRAM OR PROJECT?

The quarter fee for a Fiscal Sponsorship Fund is calculated based on the expected time needed for donor interactions and processing requests as a small percentage of the donated assets. Fees will be reviewed prior to the fund's initiation.

HOW DO WE MAKE GRANTS AND DISTRIBUTIONS?

To request distributions in accordance with the Investment Fund Agreement, a Distribution Request must be submitted through the Foundation's donor portal, along with vendor documentation. Although the request is not binding due to IRS due diligence requirements, the WCF will rely on the submitted documentation.
